## **LAERSKOOL EVERSDAL: INSKRYWINGS - 2015**

Ek neem die vrymoedigheid om ons skool vir u gunstige oorweging aan te bied. Die keuse van u kind se skool is 'n belangrike proses. Om u hiermee by te staan, neem die skool die volgende stappe:

### **1. INSKRYWING:**

- 1.1. Voltooi die inskrywingsvorme moet die skool bereik teen **6 Junie 2014**. Hierdie inligting en statistiek stel die skool in staat om die personeeltoekenning en die begroting vir 2015 af te handel. Die inligting, soos deur die skool versoek op die ingeslote vorms, is vir die skool uiters belangrik vir 'n korrekte leerlingdatastelsel. U word dus vriendelik versoek om die vorms volledig en, indien moontlik, in **drukskrif** te voltooi.

### **2. DOKUMENTASIE**

Aansoeke moet vergesel word van die volgende dokumente :

- Afskrif van voornemende leerder se **geboortesertifikaat**.
- Afskrif van voornemende leerder se **kliniekkartaat**. (**Slegs vir Gr. 1-leerders**)
- Laaste skoolrapport (**Slegs Gr. 2 – 7-leerders**).
- Bewys van woonadres van voornemende leerder. (**Jongste Munisipale rekening**).
- Afskrif van biologiese ouers of wettige voogde se **identiteitsdokumente**.
- Oordragsertifikaat van vorige skool. (**Handig in op eerste skooldag**).

### **3. GRENSE TUSSEN SKOLE / WOONGEBIEDE**

Alhoewel die natuurlike grense van die skool nie rigied en absoluut is nie, bied Bylae A 'n aanduiding van woongebiede wat waarskynlik binne die skool se natuurlike grense val.

### **4. AANSOEKERS BINNE DIE NATUURLIKE GRENSE**

Voornemende ouers uit woongebiede **binne** die skool se direkte bedieningsgebied, soos gelys in Bylae A, sal vanaf **23 Junie 2014** in kennis gestel word van aanvaarding. Ouers moet 'n skriftelike aanvaarding teen **22 Julie 2014** by die skool inhandig.

### **5. AANSOEKERS BUITE DIE NATUURLIKE GRENSE**

- 5.1 Belangstellende ouers wat **buite** hierdie genoemde direkte bedieningsgebiede woon, word gevra om Bylae B te voltooi en saam met u aansoekvorm teen **6 Junie 2014** in te lewer.
- 5.2 Voornemende ouers uit woongebiede **buite** die skool se direkte bedieningsgebied, wat Bylaag B ingesluit het by die aansoek, sal eers teen **2 September 2014** skriftelik in kennis gestel word.
- 5.3 Die skriftelike aanvaarding deur ouers van **buite** die skool se direkte bedieningsgebied, moet die skool nie later as **16 September 2014** bereik. Indien ouers nie skriftelik aanvaar nie, sal die leerder se naam op 'n waglys geplaas word.



5.4 Leerders wat reeds broers en/of susters in die skool het, moet ook **teen 6 Junie 2014** aansoek doen.

**1. APPLICATION**

- 1.1. In order to finalise teacher / pupil ratios and budgets for 2014, all application forms must be completed to reach the school by **XXXXXXX**. The information required on the included forms are of the utmost importance to maintain a correct learner data system. Please be so kind as to complete the forms in full and write in blockletters for legibility.

**2. DOCUMENTATION**

**The following must accompany applications:**

- Copy of prospective learner's birth certificate.
- Copy of prospective learner's clinic card (**Only Gr. 1 learners**).
- Latest school report (**Only Gr. 2 - 7 learners**).
- Proof of residential address of prospective learner (**Municipal account**).
- Copy of biological parents or lawful guardian's Identity Document.
- Transfer certificate from previous school. (**To be handed in on first school day**).

**3. BOUNDARIES BETWEEN SCHOOLS AND RESIDENTIAL AREAS**

Although the natural boundaries of the school are not rigid and absolute, Addendum A is an indication of residential areas which fall within the school's natural boundaries.

**4. APPLICATIONS INSIDE THE NATURAL BOUNDARIES**

Prospective parents living in residential areas **within** the school's direct feeder area, as listed in Addendum A, will be notified of acceptance from **xxxxxxx**. Parents must hand in signed acceptance of admission at the school by **xxxxxx**. If parents do not reply, the children's names will be placed on a waiting list.

**5. APPLICATIONS OUTSIDE THE NATURAL BOUNDARIES**

- 5.1 Interested parents who reside **outside** these direct feeder areas, are asked to complete Addendum B and to attach it to the application form and return it by **xxxxxxxxx**.
- 5.2 Interested parents who reside **outside** these direct feeder areas and who attached Addendum B to the application form, will only be notified whether their application was successful or not, in writing, by **xxxxxxxxx**.
- 5.3 Written confirmation by parents residing **outside** the direct feeder areas must be returned not later than **xxxxxxxxxxxx**
- 5.4 Learners with brothers and / or sisters in the school must also apply by **xxxxxxxxxxxxx**.



6. **INFORMATION EVENING:**

An **Information Evening** has been set aside for all parents (and current Pre-Primary learners) on **17 October 2013** at **18:00**. Different aspects regarding the school will be presented to you. The specific needs of new pupils will be discussed.

7. **FURTHER INFORMATION**

If you are still unsure about any aspect of your child's integration into the school after the Information Evening, or if you wish to discuss anything specific about your child, you are welcome to make an appointment with the school as from **21 October 2013** from Mondays to Thursdays. Your appointment will be handled by either the Headmaster, Deputy Head or Head of the Foundation Phase.
