**ADMISSION**

- \* Only Eversdal Primary School learners
- \* Apply at the school or Ever Aftercare

**TIMES AND SERVICES**

- \* Monday to Friday: 13:00-18:00
- \* Lunch and snacks included
- \* Supervision of learners, inclusive of homework
- \* Send learners to attend school sport
- \* Parents to inform Aftercare of paid activities
- \* Morning Care (extra):  
06:30-07:45 breakfast included
- \* School holidays (extra):  
07:30-18:00, lunch, snacks and activities included
- \* Closed on public and school public holidays
- \* Eversdal Aftercare closes at 18:00
- \* Fees are imposed if learners are fetched after 18:00

**DRESS**

- \* Appropriate to play in
- \* All items must be clearly marked
- \* Learners take responsibility for own belongings

**FINANCE**

- \* Paid in advance by direct bank deposit, debit order or EFT
- \* No cash payments accepted
- \* Written notice of termination of attendance
- \* Tuck shop available on Fridays

**FETCHING OF LEARNERS**

- \* Only by persons as indicated on application form / arranged wit Eversdal Aftercare
- \* Learners may not leave the premises on their own
- \* Parents have to sign out their children

**ABSENTEEISM**

- \* Parents have to inform Eversdal Aftercare when a learner will be absent

**RECREATION**

- \* Learners play within safe area
- \* Optional DVD after 16:00
- \* Board games, balls, etc. available

**DISCIPLINE**

- \* Learners receive clear guidelines
- \* Acknowledgement of good behaviour
- \* Should learners not adhere to the rules, the situation will be followed up/ referred to the school / parents will be contacted
- \* Cell phone policy: may only be used in the case of emergency under supervision in designated area
